## CHAPTER V LABARGE GENEALOGY WARNOFF WARNHOFF FAMILY

The earliest known ancestor on the Warnhoff(also spelled Warnof, Warnoff, Wornoff, Wornhoff) has been traced to Falmierowo, Charlottesburg(parish of Wiersitz, Prussia.) This area today is For what is known about Daniel Warnof's family see the family group sheet. in what is Poland. They(Daniel and wife, Wilhelmine Schuler) had 6 children. During the time that they lived in Prussia the area was in a constant state of warfare. They had a series of warlike leaders including Frederick the Great who were more interested in conquest than they were in bettering the lot of the citizens. Germany was not unified but was composed of several munincipalities. In the early months of 1807 Napoleon of France entered Berlin. In the treaty of Tilset, Prussia lost much of her Polish possession and her land west of the Elbe. They had several leaders after the treaty who served as leaders of Prussia but who were not born there. One such leader was Baron Stein he wanted to open the way for reforms for the people. Serfdom was doneaway with but the peasants had to cede part of their land to their Manorial Lords. This situation caused many of the peasants to move to urban areas or to emigrate to other countires. Prussia was mainly The Warnoff children who lived to maturity married in an agrarian area during this time. same parish where they were born. Child August died at age 17 and child, Wilhelmine died at age 17. Your ancestor Frederick(called Christoph Fredrich in the parish registers in Germany) married 10 Nov 1850 to Augusta Baecker in Wiersitz parish. They were married in the Evangelical church (Lutheran). The pastor was named Seigesmund.

Sometime after their marriage in 1850 and the year 1854 Christoph Fredrich (Frederick) moved to the United states and settled in St. Louis, Missouri. Since their oldest son, Robert was born in about 1851(19-1870) in Prussia and their next child Frank A.(your ancestor) was born in Jan. 1854 we can approximate when they left the old country to head for America.(1851-1853) See family sheet for record of this family. Though his name is recorded in parish records in Germany as Christoph Frederick whilein U.S. he never seemed to use his first name but went exclusively by his middle name. Between the birth of Frank and Frederick there is a space of 6 years. There may have been a child or two born in between those years that died young and didn't appear in the census. All the other children were born 2-3 years apart. There were eight known children to this couple.

The civil war began in 1861 and ended in 1865. Missouri citizens were about evenly divided between alliegence to the north and south. Augusta as Frederick's widow applied for a civil war p.ension from the U.S. Government. she stated he served in company A, 2nd M.U.S.R.C. Further that he enlisted under name Frederick Warnhoff at St. Louis 8 May 1861 in company A, 2nd regt. Mo U.S.R.C. Further that he was discharged 26 Aug. 1861. The department of Interior could not find his name listed in their records. The claim for the widow no. 461848 was rejected stating "Your husband was not in the military service of the United States as alleged as shown by the records of the war department."

The widow applied first 28 Aug. 1890. On 3 Oct 1899 Augusta appointed attorneys H.D. & R. S. O'Briend to prosecute claim. At that time she was living at 1700 N. 20th street, St. Louis, Missouri. In her deposition she declared that he husband had died in St. Louis 24 June 1878. A copy of his burial certificate was enclosed. At death he was 50 years and one month. Place of death was no. 1503 Biddle street, St. Louis, Mo. The attending physician was W.E. Fischkwl. The undertaker was L. Spelbrink. Frederick was buried at St. Peters cemetery.

On 22 July 1901 Augusta made one more deposition sent to the government which was translated from the German. "I thank you for the information which you sent me. You must excuse me but I always believed myself entitled to pension. My husband was drafted but his name was not given correctly in the newspaper. Ir was given as Fredrick Warenhoff. Ar that time we lived on Ofallon street(1861) between 8th and 9th streets and we had four children. The oldest of which was then 13 and the second 11 years old. Now they are men but remember very well when we went ot Camp Jackson to bid their father goodby, when the militia left. I also saw them - my husband amongst them - give up the guns in Mosart Hales." It was signed respectfully Auguste Warnhoff (27 July1901 CVE)

## CHAPTER FIVE LABARGE GENEALOGY WARNHOFF- Warnoff-Wornof, etc.

Frederick, the emigrant was listed in st. Louis city directories and census as being a **locks**mith. When he died he was only 51 years of age. His son, Frank S. through whom you come in also listed in the same trade as his father before him in the censuses, a locksmith.

Frank Warnhoff was born Jan 1854 in St. Louis, Missouri. For what is known about his family see the following family sheet. He would have been about 7 years of age when the civil ar started and 11 when it ended. Frank and his wife, Anna Haig were both born same year and age when they got married. I looked for near neighbors to the Warnhoff's in various censuses to if Anna's family could be located before their marriage in the 1860 census but I didn't find family. They had 7 children born between 1879-1898. Their oldest son, Charles died bef. Elsie was the next to youngest child and youngest daughter in the family. These children are born during the Gay Nineties when dresses were long and decorative. The period of popularity steam boat travel was being overshadowed during this time by the spreading of the railroad across country. The mother in reporting the number of children born to her reported the number of two children did not appear in available census they must have lived and died in between cuses. Also in the 1900 census Anna Haig is listed as a naturalized citizen but her citizenship were not on file in the records for maturalizations at St. Louis. The clerk stated that wife's naturalizations for earliest records are not always given.

St. Louis, Missouri whose post office address is 2711 Franklin Avenue well known to me to be respectable and entitled to credit, and who being duly swern, declare in relation to the aforesaid case as follows: That they have been well and personally acquainted with Augusta Warnhoff for 10 years and 17 years, respectively and that the above Augusta Warnhoff, has no means of support but her -own daily labor, laving no property or other income whatever. Further that if she h a any other means of support than the above mentioned they have every reason to believe and do believe they should have known it.
